Corporate and Operational Objectives

- Finalise sub committees and advisory groups to improve governance, support the organisation and aid transparency (Appendix 1)
- Review policies and constitution to ensure they remain relevant, clear and in line with Strategic objectives
- Implement Board and Director review process
- Complete a Board review/induction prior to new incoming Board members
- Improve information and record keeping and Board induction packs
- Address the identified areas for improvement from the 2022 DLGSCI review and target areas to improve WPWA Tier standing
- Conduct AYC competition in 2023 with support from WPA
- Conduct process for state team selection
- Provide organisational support and management for all competitions
- Liaise with other states and plan/implement 1 new competition to increase exposure of the sport
- Provide management support and guidance for new clubs, including setup and governance

Stakeholders and Facilities

- Identify political support base for the sport, and involvement in AYC, AWL and Awards night with focus on Minister for Sport
- Secure a Board position on WPA for WA rep by 2024
- Increase and clarify communication with all stakeholders via new avenue of social media and GM newsletters
- Encourage unity and celebrate the sport with pre-season function and an end of season Awards evening
- Conduct 2 president's meetings and a pre-season briefings annually
- Conduct a survey with all stakeholders at the end of the season to identify areas for improvement
- Ensure all clubs are briefed and kept up to date on the latest policies from WPWAI and WPA
- Work with asset holders to improve access to facilities and support clubs
- Increase visibility of the sport by improved communication, social media and supporting independent competition promoters (i.e. Cottesloe Cup)
- Review and action key findings from assessments and findings from annual review by DLGSCI
- Continue to work with City of Wanneroo (and other providers) to secure Water polo facilities at Alkimos City Centre
- Undertake asset assessment of pool space

Business Overview (FY2023 cont.)



People and Culture

- Partner with a charity/inclusion group as part of developing a culture of "giving" and supporting inclusiveness in the sport
- Formalise GM annual review process
- Re-structure WPWAI team roles and responsibilities to ensure it has coverage over its obligations and strategic directions
- Use networks in the sport and corporate contacts to assist in building and promoting the sport, with minimal cost to WPWAI
- Recruit a local social media person responsible for Facebook, Instagram
- Document annual reviews of WPWAI team
- Confirm and promote a code of conduct for all Board members and WPWAI employees
- Use the Nominations Committee to identify and work with future Board members – appoint independent members
- Pre-season briefing with clubs about behaviour and expectations
- Undertake workshop with Clubs to develop and work on Unity initiatives
- Utilise the services and guidance of DLGSCI in order to be aligned for funding requests and other managerial initiatives

Financial Objectives

- Manage and achieve the budget to end final position of (\$21,000) and report on monthly variances via the Audit & Finance Committee
- Fund budget position from reserves
- Broaden the range of funding sources corporate, other government grants and WPA
- Improve current banking processes to simplify payments and ensure consistency following changes in Board/WPWAI staff

Risks

- Continuation of COVID disruptions
- Reduced funding from DLGSCI and WPA or no corporate sponsorship
- Failure to address findings of reviews and DLGSCI assessment
- Not allowing for the replacement of depreciable assets
- Reduced participation rates

Opportunities

- Improve DLGSCI funding by \$30,000 for regional works
- Improve rating of Sport to a Tier 2 sporting organisation
- Increase exposure by working with private groups (Cottesloe Cup)
- Identify and support club applications for funding for community grants
